NEW STUDENT PROTECTION SCHEME (SPS) PROVIDERS

We would like to inform you that the Pro-tem Council for Private Education has appointed five (5) Student Protection Scheme (SPS) providers for the EduTrust Certification scheme which will replace the CaseTrust for Education scheme.

During the transition of CaseTrusted PEOs applying for EduTrust certification, your school can sign up with any of the five providers. Pro-tem Council for Private Education is organising a seminar in October 2009 to introduce the new providers and you will receive the invitation in due course.

For Escrow banks, Standard Chartered Bank is the new addition to the current providers. The current Escrow banks; DBS and HSBC will continue to provide their services. HSBC Insurance and Lonpac Insurance will be the new insurance providers.

As the new insurers will need around two weeks to process your Student Protection Scheme application, **all CaseTrusted PEOs who only have Student Protection Scheme with NTUC Income will need to sign up with any of the five providers by 15 October 2009.** *This deadline is **not** applicable to schools that already have an existing Escrow Account and do not need Insurance under Student Protection Scheme; you can decide to sign up with the new provider(s) after attending the above-mentioned seminar.*

Please be advised that CaseTrust reserves the right to suspend the accreditation status of PEOs that do not have a valid Student Protection Scheme at any point in time.
